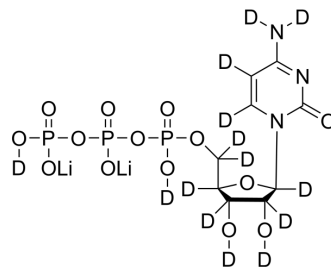

<b>Description</b>	Cytidine-5'-triphosphate-d <sub>14</sub> (Cytidine triphosphate-d <sub>14</sub> dilithium; 5'-CTP-d <sub>14</sub> ) dilithium is deuterium labeled Cytidine-5'-triphosphate (HY-125818). Cytidine 5'-triphosphate (Cytidine triphosphate; 5'-CTP) is a nucleoside triphosphate and serves as a building block for nucleotides and nucleic acids, lipid biosynthesis. Cytidine triphosphate synthase can catalyze the formation of cytidine 5'-triphosphate from uridine 5'-triphosphate (UTP). Cytidine 5'-triphosphate is an essential biomolecule?in the de novo?pyrimidine biosynthetic pathway in?T. gondii.
<b>In Vitro</b>	Stable heavy isotopes of hydrogen, carbon, and other elements have been incorporated into drug molecules, largely as tracers for quantitation during the drug development process. Deuteration has gained attention because of its potential to affect the pharmacokinetic and metabolic profiles of drugs <sup>[1]</sup> .
