Background

MDH2, a critical enzyme, undergoes acetylation, which leads to an increase in its enzymatic activity. This post-translational modification acts as a regulatory mechanism for MDH2, potentially impacting its functionality and playing a role in the modulation of cellular metabolic processes. Understanding the specific effects of acetylation on MDH2 can provide insights

	into the regulation of metabolic pathways and may have implications for diseases related to metabolic dysregulation.
